



MARINER MEMBERSHIP INFORMATION

MARINER MEMBERSHIP: Mariner Members shall be entitled to the rights and privileges, and be subject to the duties and obligations, hereinafter set forth.

DUES AND CONTRIBUTIONS: Mariner Members shall pay a one-time non-refundable fee of \$1,000.00 at the time of admission, \$500.00 of which is due upon application. This fee will be applied to the Membership Fee when there is a conversion to Flag Membership. Dues and contributions to the building fund shall be the same as those paid by Flag Members.

VOTING: Mariner Memberships shall not have voting privileges and shall not be eligible for election to the Board of Directors, or hold any Staff or Flag Office. They shall, however, be eligible to serve on any of the Club's committees and are encouraged to do so.

SPONSOR: The proposal for Membership in the Mariner category needs to be signed by one sponsor only. The applicant shall be subject to review by the Admissions Committee and approved by the Board of Directors prior to admission. The applicant shall also be subject to posting for the period required for Flag applicants.

MEMBERSHIP FEE: The Membership Fee to be paid upon conversion for Flag Membership shall be the fee for Flag Membership, which exists at the time of conversion. The original \$1000.00 paid at the time of admission is credited to the purchase of the Flag Membership.

CONVERSION TO FLAG MEMBERSHIP: For those Mariners with a boat at DRYC, or for those on a slip waiting list, it is required that you convert to Flag Membership within **18 months** of being accepted as a Mariner Member. MARINERS WITHOUT A DRYC SLIP OR DRY STORAGE OR THAT ARE NOT ON A SLIP WAITING LIST ARE NOT REQUIRED TO CONVERT TO FLAG MEMBERSHIP, but may continue as a CORINTHIAN MEMBER without further processing.

Mariners that do convert are required to be re-interviewed by the Admissions Committee and reconfirmed by the Board of Directors. They will be notified prior to the end of their 18-month time period and will have 30 days to submit their application for Flag Membership. A Mariner's failure to make application within 30 days after notification constitutes automatic termination of the Member's Membership.

PRIVILEGES: Mariner Members shall enjoy all of the privileges of Flag Members except voting, the ability to hold office, and slip privileges except as hereinafter provided, and are encouraged to serve on Club Committees.

SLIP PRIVILEGES: Mariner Members shall have slip privileges on a month-to-month basis subject to availability and may go on the Slip Waiting List. However, the Mariner must convert to Flag Member when he or she is offered the slip on a permanent basis. Should a Flag Member be offered the slip occupied by the Mariner Member, the Mariner Member may keep the slip by applying for a Flag Membership within 10 days of notification.
